

Community Guidelines:

Community Members are users which are using the services provided by Derivative Gaming Services*¹

Community Staff are members who can and are willing to assist Community Members with issues pertaining to Community Standards and Guidelines.

Every user must uphold an appropriate manner within Derivative Gaming Services*¹

All Community Members are welcome to join and leave. If that Community Member has not broken any Community Guidelines requiring permanent removal from Derivative Gaming Services*¹

Permanent community removals are only provided after our 3-Step*⁴ member warning process, this includes social media including discord channels.

Community Members cannot receive personal payments and/or profiteer from services rendered within Derivative Gaming Services*¹.

Community Member Guidelines:

- Must uphold reasonable manners
- Must **NOT** harass members
- Must **NOT** post inappropriate text or images
- Must **NOT** poach members too or from Derivative Gaming Services*¹
- Must uphold the integrity of Derivative Gaming Services*¹
- Must **NOT** advertise Other Services*² on Derivative Gaming Services*¹
- Must report member issues to Community Staff within a reasonable timeframe.
- Must follow any reasonable request*³ from Community Staff.
- Must not gain personal profits from services rendered within Derivative Gaming Services*¹

Community Staff Guidelines:

Community Staff jurisdiction is on Derivative Gaming Services*¹ outside of Server Staff jurisdiction and does not overrule Server Staff jurisdiction.

- Must follow Community Member Guidelines
- May make reasonable community decisions within the Community Guidelines
- Must assist members with any community issues
- Must inspect and report Derivative Gaming Services*¹ for Community Guideline breakages
- Must **NOT** overrule jurisdiction on Derivative Gaming Services*¹ E.G. Community Staff cannot join a server and overrule a Server Staff on Server Rule Breakages. But can inspect and report any Community Guideline Breakages made by Server Staff and on Derivative Gaming Services*¹.
- Must contact Server Staff regarding Community Guideline breakages

Server Staff Guidelines:

Server staff jurisdiction is on the Server in which they have been placed as Server Staff, must respond to all reports made by Community Staff. This includes Server Hosts.

- Must follow Community Members Guideline
- May make reasonable server decisions within the Server Rules and Community Guidelines
- Must assist players and members with server issues

- Must NOT overrule jurisdiction on Derivative Gaming Services*¹, E.G. Server Staff do not have jurisdiction on Social Media related to the Server they have been assigned staff.

Co-Owner/Founder Guidelines:

Co-Owner/Founder jurisdiction is over all Derivative Gaming Services*¹, make decisions based on Community Guidelines and report any issues to the appropriate Community/Server Staff when a member is requiring assistance.

Banning (per service):

- Servers:
 - Temporary Ban
 - Temporary Ban can be used to temporarily ban users/members if the function does not permanently ban the user from using other Derivative Gaming Services*¹
 - Permanent Ban
 - Permanent Ban should be used for members that break community guidelines, but staff must adhere to the 3-Step*⁴ member warning process.
- Discord/Social Media:
 - Roles Removal
 - This is the first step to remove members from Discord if Community Guidelines are broken.
 - Kick
 - Should only be used for members that break community guidelines, but staff must adhere to the 3-Step*⁴ member warning process. Staff roles will not be reinstated if member rejoins and kick from the Derivative Gaming Services*¹ was reasonable.
 - Ban
 - Should be used for members that severely break community guidelines and/or cause intentional harm to Derivative Gaming Services*¹

Purchase and Donation information:

As we are not a charity, we do not accept donations. We classify donations as any money received without a form of service provided to the user. When a purchase is made, a service or material must be provided/rendered.

Purchases are to be made on a service rendered basis and only when specified by Derivative Gaming Services*¹. Members cannot ask for payment for services rendered unless specified by Derivative Gaming Services*¹.

*¹ Derivative Gaming Services include servers, social media, discord, voice chat and any other services rendered with Derivative Gaming details.

*² Other Services include services classified as available on Derivative Gaming Services*¹.

*³ Reasonable requests made are pertaining to and upholding community standards within the community guidelines.

*⁴ 3-Step process is as follows. Community Members that break Community Guidelines will receive 3 Warnings before Permanent Removal.

- **First** warning will be a verbal warning with no service accessibility repercussions, however removal of content of member on the service may occur.
- **Second** warning will come with a kick from the service in which the user has continued to break the Community Guidelines.
- **Third** Warning will come with a Temporary Removal from the service in which the member has continued to break the Community Guidelines.

Permanent Removal from all Derivative Gaming Services*¹ will only be rendered if the user is breaking Community Guidelines in multiple services.
